1. WHAT INFORMATION DO WE COLLECT?

Personal information you disclose to us

In Short: We collect personal information that you provide to us.

We collect personal information that you voluntarily provide to us when you express an interest in obtaining information about us or our products and Services, when you participate in activities on the Services, or otherwise when you contact us.

Personal Information Provided by You. The personal information that we collect depends on the context of your interactions with us and the Services, the choices you make, and the products and features you use. The personal information we collect may include the following:

- Names
- Demographic data (age, country, gender, and preferred language)
- Business affiliation
- Phone numbers
- Email addresses
- Job titles and department
- Mailing addresses
- Contact preferences
- Feedback data (service feedback, survey data, and service reviews)
- Response to interventions and education
- Workplace environment and associated physical demands
 - Attendance/interaction history
 - Workstation equipment setup
 - Ergonomics assessment and hazard identification information
 - Job tasks
 - Current and historical areas of physical discomfort
 - Subjective information related, or non-related, to the workplace
 - Workplace hazards using ergonomic assessment observational, subjective, and quantitative outcome tools

Sensitive Information. We do not process sensitive information.

All personal information that you provide to us must be true, complete, and accurate, and you must notify us of any changes to such personal information.

Information collected from other sources

In Short: We may collect limited data from public databases, marketing partners, and other outside sources.

In order to enhance our ability to provide relevant marketing, offers, and services to you and update our records, we may obtain information about you from other sources, such as public databases, joint marketing partners, affiliate programs, data providers, and from other third parties. This information includes mailing addresses, job titles, email addresses, phone numbers, intent data (or user behavior data), Internet Protocol (IP) addresses, social media profiles, social media URLs, and custom profiles, for purposes of targeted advertising and event promotion.

2. HOW DO WE USE YOUR INFORMATION?

In Short: We use your information to provide, improve, and administer our Services, communicate with you, for security and fraud prevention, and to comply with law. We may also use your information for other purposes with your consent.

We use your personal information for a variety of reasons, depending on how you interact with our Services, including:

- **To deliver and facilitate delivery of services to the user.** We may use your information to provide you with the requested service.
- **To provide data analytics to your sponsoring organization.** When the services are offered to you as part of a benefits program by your “Sponsoring Organization”, we may use your personal information, including but not limited to your name, department/job title, observed workstation issues, and your reported physical issues and concerns as they relate to your job tasks.
- **To respond to user inquiries/offer support to users.** We may use your information to respond to your inquiries and solve any potential issues you might have with the requested service.
- **To send administrative information to you.** We may use your information to send you details about our products and services, changes to our terms and policies, and other similar information.
- **To request feedback.** We may use your information when necessary to request feedback and to contact you about your use of our Services.
- **To send you marketing and promotional communications.** We may use the personal information you send to us for our marketing purposes, if this is in accordance with your marketing preferences. - **To post testimonials.** We post testimonials on our Services that may contain personal information.
- **To protect our Services.** We may use your information as part of our efforts to keep our Services safe and secure, including fraud monitoring and prevention.
- **To evaluate and improve our Services, products, marketing, and your experience.** We may use your information when we believe it is necessary to identify usage trends, determine the effectiveness of our promotional campaigns, and to evaluate and improve our Services, products, marketing, and your experience.

- **To comply with our legal obligations.** We may use your information to comply with our legal obligations, respond to legal requests, and exercise, establish, or defend our legal rights.

3. WHEN AND WITH WHOM DO WE SHARE YOUR PERSONAL INFORMATION?

In Short: We may share information in specific situations described in this section and/or with the following third parties.

We may need to share your personal information in the following situations:

- **Business Transfers.** We may share or transfer your information in connection with, or during negotiations of, any merger, sale of company assets, financing, or acquisition of all or a portion of our business to another company.
- **Sponsoring Organization.** We may share your information with your sponsoring organization if you are receiving the services on behalf of a sponsoring organization. We may share your personal information as follows:
 - Attendance/interaction history
 - Workstation equipment setup and modifications
 - Interventions and education provided during interaction, along with response to interventions.
 - Ergonomics assessment and hazard identification information
 - Job tasks
 - Current and historical areas of physical discomfort
 - Subjective information related, or non-related, to the workplace
 - Workplace hazards using ergonomic assessment observational, subjective, and quantitative outcome tools

4. HOW LONG DO WE KEEP YOUR INFORMATION?

In Short: We keep your information for as long as necessary to fulfill the purposes outlined in this privacy notice unless otherwise required by law.

We will only keep your personal information for as long as it is necessary for the purposes set out in this privacy notice, unless a longer retention period is required or permitted by law (such as tax, accounting, or other legal requirements).

When we have no ongoing legitimate business need to process your personal information, we will either delete or anonymize such information, or, if this is not possible (for example, because your personal information has been stored in backup archives), then we will securely store your personal information and isolate it from any further processing until deletion is possible.

5. HOW DO WE KEEP YOUR INFORMATION SAFE?

In Short: We aim to protect your personal information through a system of organizational and technical security measures.

We have implemented appropriate and reasonable technical and organizational security measures designed to protect the security of any personal information we process. However, despite our safeguards and efforts to secure your information, no electronic transmission over the Internet or information storage technology can be guaranteed to be 100% secure, so we cannot promise or guarantee that hackers, cybercriminals, or other unauthorized third parties will not be able to defeat our security and improperly collect, access, steal, or modify your information. Although we will do our best to protect your personal information, transmission of personal information to and from our Services is at your own risk. You should only access the Services within a secure environment.

6. DO WE COLLECT INFORMATION FROM CHILDREN?

In Short: We do not knowingly collect data from or market to children under 16 years of age.

Our products and services are not intended for use by minors, and we do not knowingly solicit data from or market to children under 16 years of age. By using the Services, you represent that you are at least 16 or that you are the parent or guardian of such a minor and consent to such minor dependent's use of the Services.

7. WHAT ARE YOUR PRIVACY RIGHTS?

In Short: You may review, change, or terminate your account at any time.

Withdrawing your consent: If we are relying on your consent to process your personal information, which may be express and/or implied consent depending on the applicable law, you have the right to withdraw your consent at any time. 8. CONTROLS FOR DO-NOT-TRACK FEATURES

We will use and retain the collected personal information as needed to provide the Services or for:

- Category A - As long as the user has an account with us
- Category B - As long as the user has an account with us

- Category G - As long as the user has an account with us

We may also collect other personal information outside of these categories through instances where you interact with us in person, online, or by phone or mail in the context of:

- Receiving help through our customer support channels;
- Participation in customer surveys or contests; and
- Facilitation in the delivery of our Services and to respond to your inquiries.
